CORPORATE RIVALS CODE OF CONDUCT

The purpose of Corporate Rivals Leagues is to provide players the opportunity to participate in a variety of sports and recreational activities. These activities are designed to promote good, clean competition and fair sportsmanship for all to enjoy. Please read the following form, sign it and return it to the League director, in order to participate in any of the leagues at Sportshouse.

NO PLAYER SHALL: At any time lay a hand upon, shove, strike or threaten an official. Officials are required to immediately suspend the player from further play and report such player to the League director. Such players shall remain suspended until his/her case has been considered by League Management.

NO PLAYER SHALL: Inappropriately demonstrate dissent of official's decision or be guilty of verbal or forceful demonstration of dissent to an official's decision.

NO PLAYER SHALL: use deliberately rough tactics during a game against the body and person of an opposing team. Officials are required to immediately suspend participants from further play and report incidents to the League Director.

NO PLAYER SHALL: be guilty of intentionally throwing any playing equipment. Officials are required to immediately suspend the participant from further play and report such player to the League Director.

NO PLAYER SHALL: be guilty of leaving his/her offensive, defensive position to further incite any verbal or physical confrontation between players on the field or court.

NO PLAYER SHALL: be guilty of an abusive verbal attack, including "trash talking" or taunting any participant, officials, representatives, or spectator. Officials are required to immediately suspend the participant from further play. The infraction will be reported to the

League Director. This violation additionally includes "after the incident" communication or correspondence in the follow up discussions.

NO TEAM OR TEAMS SHALL engage in physical aggression upon each other, officials, agency representatives, or spectators. Officials shall immediately suspend play and report, in writing, the incident to the League Director.

SPECIAL NOTES:

- 1. Upon any and all violations of the Code of Conduct. In any violation not included in said Code, the penalty shall be at the discretion of the League director.
- 2. Any participant removed from a game must leave the field or court immediately. Failure to do so will carry a maximum penalty of one-year suspension.
- 3. Any participant having been once penalized by enforcement of the "Code of Conduct" and reported again for violating the "Code of Conduct" will be subject to additional penalties open to determination Corporate Rivals Management.
- 4. Any individual or team who is placed on probation or suspensions for violation of items aforementioned in this Code of Conduct is automatically on probation or suspension for ALL ACTIVITIES sponsored by the fitness center.

The League Director shall have the power and full discretion of imposing penalties on all violations of Players Code of Conduct. For any inappropriate conduct not expressly included in said Code, the penalty shall be at the discretion of Corporate Rivals Management.
